## **ELIGIBILITY REQUIREMENTS**

To qualify for a concealed carry permit in Maryland, applicants must meet the following criteria:

- Minimum 21 years old.
- No felony or disqualifying misdemeanor convictions, substance abuse issues, or mental health problems.
- Completion of a state-approved firearms training course (16 hours) within two years of submitting the application.
- No active restraining orders or domestic violence convictions.

Students will receive feedback on the live-fire exercise, a NRA CCW Course certificate of completion, Qualification score sheet & the Affidavit required to be submitted for the license application. A brief written exam will be presented throughout the classroom instruction portion of the course.

MUST BE A DELAWARE RESIDENT TO APPLY

## **QUALIFICATION REQUIREMENTS**

§ 1441. License to carry concealed deadly weapons.

(a) A person of full age and good moral character desiring to be licensed to carry a concealed deadly weapon for personal protection or the protection of the person's property may be licensed to do so when the following conditions have been strictly complied with:

(1) The person shall make application therefor in writing and file the same with the Prothonotary of the proper county, at least 15 days before the then next term of the Superior Court, clearly stating that the person is of full age and that the person is desirous of being licensed to carry a concealed deadly weapon for personal protection or protection of the person's property, or both, and also stating the person's residence and occupation. The person shall submit together with such application all information necessary to conduct a criminal history background check. The Superior Court may conduct a criminal history background check pursuant to the procedures set forth in Chapter 85 of Title 11 for the purposes of licensing any person pursuant to this section.

(2) At the same time the person shall file, with the Prothonotary, a certificate of 5 respectable citizens of the county in which the applicant resides at the time of filing the application. The certificate shall clearly state that the applicant is a person of full age, sobriety and good

moral character, that the applicant bears a good reputation for peace and good order in the community in which the applicant resides, and that the carrying of a concealed deadly weapon by the applicant is necessary for the protection of the applicant or the applicant's property, or both. The certificate shall be signed with the proper signatures and in the proper handwriting of each such respectable citizen.

(3) Every such applicant shall file in the office of the Prothonotary of the proper county the application verified by oath or affirmation in writing taken before an officer authorized by the laws of this State to administer the same, and shall under such verification state that the applicant's certificate and recommendation were read to or by the signers thereof and that the signatures thereto are in the proper and genuine handwriting of each. Prior to the issuance of an initial license the person shall also file with the Prothonotary a notarized certificate signed by an instructor or authorized representative of a sponsoring agency, school, organization or institution certifying that the applicant: (i) has completed a firearms training course which contains at least the below described minimum elements; and (ii) is sponsored by a federal, state, county or municipal law enforcement agency, a college, a nationally recognized organization that customarily offers firearms training, or a firearms training school with instructors certified by a nationally recognized organization that customarily offers firearms training. The firearms training, course shall include the following elements:

- a. Instruction regarding knowledge and safe handling of firearms;
- b. Instruction regarding safe storage of firearms and child safety;
- c. Instruction regarding knowledge and safe handling of ammunition;
- d. Instruction regarding safe storage of ammunition and child safety;
- e. Instruction regarding safe firearms shooting fundamentals;
- f. Live fire shooting exercises conducted on a range, including the expenditure of a minimum of 100 rounds of ammunition;
- g. Identification of ways to develop and maintain firearm shooting skills;
- h. Instruction regarding federal and state laws pertaining to the lawful purchase, ownership, transportation, use and possession of firearms;
- i. Instruction regarding the laws of this State pertaining to the use of deadly force for self defense; and

j. Instruction regarding techniques for avoiding a criminal attack and how to manage a violent confrontation, including conflict resolution.

(4) At the time the application is filed, the applicant shall pay a fee of \$65 to the Prothonotary issuing the same.

(5) The license issued upon initial application shall be valid for 3 years. On or before the date of expiration of such initial license, the licensee, without further application, may renew the same for the further period of 5 years upon payment to the Prothonotary of a fee of \$65, and upon filing with said Prothonotary an affidavit setting forth that the carrying of a concealed deadly weapon by the licensee is necessary for personal protection or protection of the person's property, or both, and that the person possesses all the requirements for the issuance of a license and may make like renewal every 5 years thereafter; provided, however, that the Superior Court, upon good cause presented to it, may inquire into the renewal request and deny the same for good cause shown. No requirements in addition to those specified in this paragraph may be imposed for the renewal of a license.

(b) The Prothonotary of the county in which any applicant for a license files the same shall cause notice of every such application to be published once, at least 10 days before the next term of the Superior Court. The publication shall be made in a newspaper of general circulation published in the county. In making such publication it shall be sufficient for the Prothonotary to do the same as a list in alphabetical form stating therein simply the name and residence of each applicant respectively.

(c) The Prothonotary of the county in which the application for license is made shall lay before the Superior Court, at its then next term, all applications for licenses, together with the certificate and recommendation accompanying the same, filed in the Prothonotary's office, on the 1st day of such application.

(d) The Court may or may not, in its discretion, approve any application, and in order to satisfy the Judges thereof fully in regard to the propriety of approving the same, may receive remonstrances and hear evidence and arguments for and against the same, and establish general rules for that purpose.

(e) If any application is approved, as provided in this section, the Court shall endorse the word "approved" thereon and sign the same with the date of approval. If not approved, the Court shall endorse the words "not approved" and sign the same. The Prothonotary, immediately after any such application has been so approved, shall notify the applicant of such approval, and following receipt of the notarized certification of satisfactory completion of the firearms training course requirement as set forth in paragraph (a)(3) of this section above shall issue a proper license, signed as other state licenses are, to the applicant for the purposes provided in this section and for a term to expire on June 1 next succeeding the date of such approval.

(f) The Secretary of State shall prepare blank forms of license to carry out the purposes of this section, and shall issue the same as required to the several Prothonotaries of the counties in this State. The Prothonotaries of all the counties shall affix to the license, before lamination, a photographic representation of the licensee.

(g) The provisions of this section do not apply to the carrying of the usual weapon by the police or other peace officers.

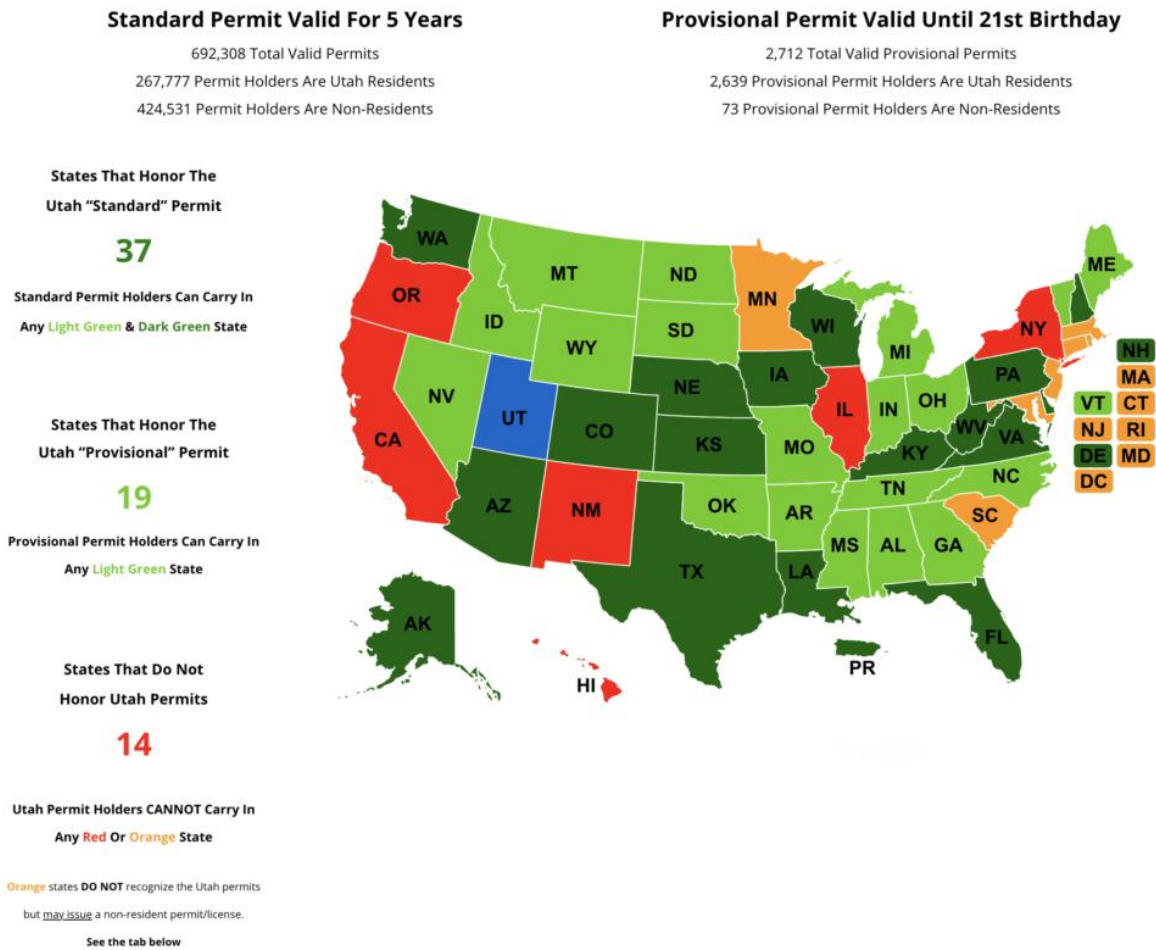

## **RANGE FEES & AMMUNITION (IF NEEDED) ADDITIONAL CHARGE**

Course Goal: Teaches the basic knowledge, skills and attitude necessary to carry a concealed pistol for personal defense. The NRA CCW Course is intended for all individuals regardless of previous shooting experience or NRA-affiliation. This instructor-led only course gives you direct instruction from an NRA-certified instructor from beginning to end and may be conducted in a classroom and on a shooting range with an instructor.

**More Details:**

NRA CCW: NRA CCW takes place in a traditional classroom and range environment. This course may be completed in a single day format or over several days with smaller blocks of instruction. To sign up for the NRA CCW Course click on the "Find A Course" icon. This opens the Course Listing page where you will select the NRA Basic CCW and scroll to the bottom of the page to enter details that refine the search criteria to generate a list of available courses. After selecting a course, you will enter your information in the registration fields. The course Instructor will contact you shortly thereafter. More Details: Course topics include: Firearm Safety (Mandatory), Pistol Nomenclature and Selecting a Pistol for Self-Defense, Basic Defensive Pistol Skills, Drawing from Concealment, Loading and Stoppage Remediation, Mindset, Carry Modes and Pistol Concealment, Firearm Cleaning, and Sport Shooting and Training Activities. Course length is determined by the instructor, to meet your State's requirements for a CCW permit. Additionally, students may complete live fire training and a nationally standardized shooting qualification while on the range with an NRA Certified Instructor. Students will receive reference books, take a NRA CCW Student Examination and receive a course completion certificate bearing the signature of the NRA Secretary and your NRA Certified Instructor.

# **PERSONAL PROTECTION IN HOME COURSE INFO**

**CLASS FEE: \$150**

**RANGE FEES & AMMUNITION (IF NEEDED) ADDITIONAL CHARGE**

## REQUIRED DOCUMENTS

- Valid Photo ID

This course teaches the basic knowledge, skills, and attitude essential to the safe and efficient use of a handgun for protection of self and family, and provides information on the law-abiding individual's right to self-defense.

**Prerequisite:** This course is for law-abiding adult citizens, as defined by applicable federal, state or local law, and experienced shooters (shooters able to show mastery of the basic skills of safe gun handling, shooting a group, zeroing the firearm, and cleaning the firearm). Prospective participants can demonstrate that they have the requisite knowledge, skills, and attitudes by producing an NRA Basic Pistol Course Certificate, NRA FIRST Steps Course Certificate, NRA pistol competitive shooting qualification card, military DD 214 with pistol qualification, or passing the Pre-Course Assessment.

**Description:** This is an eight-hour course. Students should expect to shoot approximately 100 rounds of ammunition. Students will learn basic defensive shooting skills; strategies for home safety and responding to a violent confrontation; firearms and the law; how to choose a handgun for self-defense; and continued opportunities for skill development. Students will receive the NRA Guide to the Basics of Personal Protection In The Home handbook, NRA Gun Safety Rules brochure, the Winchester/NRA Marksmanship Qualification booklet, and course completion certificate.

**Note:** Lesson III of this course—Firearms and the Law, and Legal Aspects of Self-Defense—is conducted by an attorney licensed to practice law within the state in which this course is given and who is familiar with this area of the law; a Law Enforcement Officer (LEO) who possesses an intermediate or higher Peace Officer Standards and Training (POST) certificate granted within the state; or an individual currently certified to instruct in this area of the law by the state in which this course is presented. NRA certified instructors may conduct this lesson only if they meet the requirements stated above, and then only in their capacity as an attorney or other state certified individual, not in their capacity as an NRA certified instructor.

# PERSONAL PROTECTION OUTSIDE HOME COURSE INFO

**CLASS FEE: \$150**

## RANGE FEES & AMMUNITION (IF NEEDED) ADDITIONAL CHARGE

### REQUIRED DOCUMENTS

- Valid Photo ID

This course teaches students the knowledge, skills and attitude essential for avoiding dangerous confrontations and for the safe, effective and responsible use of a concealed pistol for self-defense outside the home.

**Prerequisite:** This course is for adult individuals who are not disqualified from possessing a firearm as defined by applicable federal, state or local law and are of good repute and possess defensive pistol skills presented in the NRA Basics of Personal Protection In The Home Course. Participants must also understand the basic legal concepts relating to the use of firearms in self-defense, and must know and observe not only general gun safety rules but also those safety principles that are specific to defensive situations. Prospective participants can demonstrate that they have the requisite knowledge, skills and attitudes by producing an NRA Basic Personal Protection In The Home Course Certificate, or by passing the pre-course evaluation.

**Description:** The course is divided into two levels. Level one is nine hours and offers the essential knowledge and skills that must be mastered in order to carry, store, and use a firearm safely and effectively for personal protection outside the home. Students spend several hours on the range and shoot approximately 100 rounds of ammunition during level one. Upon completion, students may choose to attend level two, which is an additional five hours on the range and approximately 115 rounds of ammunition learning advanced shooting skills. Time and ammunition requirements are minimum and may be exceeded. Students will receive the NRA Guide to the Basics of Personal Protection Outside The Home handbook, NRA Gun Safety Rules brochure and appropriate (level one/level two) course completion certificates(s).

**Note:** Lesson III—Firearms and the Law, and Legal Aspects of Self-Defense—of the Personal Protection In And Outside The Home courses is conducted by an attorney licensed to practice law within the state in which this course is given and who is familiar with this area of the law; a Law Enforcement Officer (LEO) who possesses an intermediate or higher Peace Officer Standards and Training (POST) certificate granted within the state' or an individual currently certified to instruct in this area of the law by the state in which this course is presented. NRA certified instructors may conduct this lesson only if they meet the requirements stated above, and then only in their capacity as an attorney or other state certified individual, not in their capacity as an NRA certified instructor.

# RANGE SAFETY OFFICER COURSE INFO

## REQUIRED DOCUMENTS

- Valid Photo ID

Develops NRA Certified Range Safety Officers with the knowledge, skills, and attitude essential to organizing, conducting, and supervising safe shooting activities and range operations.

Attendees must be age 21 or above.

This course is nine hours long and is conducted in a classroom and at a shooting facility. Range Safety Officer candidates will learn roles and responsibilities of an RSO; Range Standard Operating Procedures (SOPs); range inspection; range rules; range briefings; emergency procedures; and firearm stoppages and malfunctions. Each Range Safety Officer Candidate will receive an RSO Student Study Guide, a Basic Firearm Training Program brochure, an NRA Gun Safety Rules brochure and a Course Evaluation form.

## ELIGIBILITY REQUIREMENTS

- Be 18 years of age or older
- Have a clear criminal record and not be prohibited by any federal, state, or local law, ordinance or regulation from possessing, purchasing, or using firearms.
